The NIST CSF and SP 800-53 set forth detailed security and privacy controls that organizations must implement to protect sensitive information. These regulations apply to all organizations handling sensitive information, including subcontractors.

Compliance verification

You should incorporate this information as part of your compliance program and request other partners provide a compliance checklist and/or an Executive Summary Risk Assessment annually.
